SECOND ARTICLES OF AMENDMENT

OF

The Articles of Incorporation of WILKES FOUNDATION, INC., a Florida not-for-profit Corporation, are hereby amended in the following manner:

1. Article VIII of the Articles is hereby deleted in its entirety and the following is inserted in its place:

ARTICLE VIII Board of Trustees

Control of the affairs of the corporation shall be vested in the Board of Trustees consisting of not less than two (2) Trustees, who shall be elected on an annual basis, but the term of office of any member of the Board of Trustees may be for a period of more than one (1) year as provided in the Bylaws. The number of Trustees may be increased or decreased, by an eighty percent (80%) vote of the Board of Trustees, but shall never be less than two (2) Trustees. The Board of Trustees shall be elected by the Board of Trustees at the annual meeting of the Board of Trustees. Vacancies on the Board of Trustees shall be filled by an eighty percent (80%) vote of the remaining members of the Board. Any member of the Board of Trustees elected by the Board of Trustees to fill a vacancy shall hold office until the next annual meeting of the Board of Trustees. Each member of the Board of Trustees need not be a member of the corporation as a condition precedent to election or appointment to the Board. The Board of Trustees may be organized into one (1) or more separate categories of Trustees as provided in the Bylaws.
