Articles of Amendment To Articles of Incorporation

Article I

The Corporation formerly known as "Visions Ministries, Inc.", will henceforth be known as "Visions Ministries Apostolic, Inc."

The principle place of business of this corporation shall be:
2107 Cassia Circle Apt. F, Kissimmee, FL 34741

Article III

The purpose of Visions Ministries Apostolic, Inc. shall be to establish The Paul Refuge Centers for the purpose of training people how to live life with God. ...I am come that they might have life, and that they might have it more abundantly. John 10:10b Teaching abundant living, in accordance with the three principles: love, obedience, and enjoyment as stated in the by-laws of the corporation. Having the authority to purchase, own, manage, remodel and dispose of property; to organize churches, conferences, educational institutions; to teach, preach, pray, counsel; to set-up religious radio and television programming; to conduct seminars and workshops; to license and ordain workers according to and consistent with the doctrine of Visions Ministries Apostolic, Inc.

Article IV

SECTION 1. MEMBERSHIP. Membership in Visions Ministries Apostolic, Inc. shall be open to anyone who has repented of their sins; who has been baptized in The Name of the Lord Jesus Christ for the remission of their sins; and, who has received the gift of the Holy Ghost, speaking with other tongues as the Spirit of God gives utterance, according to Acts 2:38 and Acts 2:4.

SECTION 2. FELLOWSHIPPING OF MEMBERS. Members agree to be ruled and governed by The Word of God; by the by-laws of Visions Ministries Apostolic, Inc., as set forth by The Word of God; by what will subsequently be learned through their study and the teaching of The Word of God.

SECTION 3. CHURCH AFFILIATION. Church affiliation shall be open to all who agree to and continue to teach, preach, and practice the doctrine set forth by The Word of God regarding membership defined by Acts 2:38 and Acts 2:4; agree to and continue to abide by the by-laws of Visions Ministries Apostolic, Inc., as defined by The Word of God; have a pastor licensed by Visions Ministries Apostolic, Inc.
