**ARTICLES OF AMENDMENT
TO THE
SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
TAMPA BAY BUSINESSES FOR CULTURE AND THE ARTS, INC.**

The Articles of Incorporation of Tampa Bay Businesses for Culture and the Arts, Inc., a Florida not for profit corporation formerly known as Tampa Bay Business Committee for the Arts, Inc., and Tampa Business Committee for the Arts, Inc., respectively (the "Corporation"), were originally filed with the Florida Department of State on September 28, 1988, and assigned Florida Document Number N28573. The Corporation's Articles of Incorporation were most recently amended and restated on December 28, 2012. Pursuant to Section 617.1006, the Corporation hereby further amends its Second Amended and Restated Articles of Incorporation as follows:

1. The name of the Company is Tampa Bay Businesses for Culture and the Arts, Inc.

2. Article I of the Second Amended and Restated Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

"ARTICLE I. NAME

The name of the Corporation is Tampa Bay Business Coalition for the Arts, Inc."

3. The Corporation does not have any members. The foregoing amendment was adopted by the board of directors on October 23, 2024.
