

I. NAME:

III. CORPORATE NATURE

This Paragraph shall remain the same.

IV. GENERAL AND SPECIFIC PURPOSES

A. The first Paragraph shall be amended to read

The specific and primary purposes for which this Corporation is formed are to carry on and advance the DIABETES AWARENESS PROGRAM as promoted by the INTERNATIONAL ASSOCIATION OF LIONS CLUBS.
