Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

ARTICLE XII, AMENDMET TO THE ARTICLE OF INCORPORATION APPROVED AND AMENDED.

Destitution of the pastor. If the pastor in the course of his functions is rejected or repudiated by 51% of the active members of the church, he should resign from his function as pastor. In the event, he does not resign the shall be considered by the church destitute.

POINT I). - The church members were informed about the fairness of the number of votes presently required to make the Church's Pastor cease immediately on his pastoral functions: **ARTICLE XII - Destitution** of the pastor. If the pastor in the course of his functions is rejected or repudiated by 30% of the active members of the church, he should resign from his function as pastor. In the event, he does not resign he shall be considered by the church destitute.

POINT II). - Consequently, it was proposed to increase the actual number of votes from the present 30% to a 51%. Therefore, as of the date of this meeting, a 51% of votes majority will be required to execute any action as referred on Point I herein.

AMENDMENT TO CORPORATE STATUTES, RULES AND REGULATIONS AS OF SUNDAY, JANUARY 30, 2000

This Amendment to "Iglesia Bautista Redención's" present Corporate Statutes, Rules & Regulations, comes to effect according to the special meeting indicated at the ARTICLE XVII "AMENDMENTS TO ARTICLE OF INCORPORATION" from the existing IBR Constitution, and proposed by Pastor Tomas Diaz, following directions from ARTICLE XI "PASTORAL FUNCTIONS" The pastor shall direct, orient, encourage, and protect the members that form part of the congregation; Where states that his sole responsibility It is acknowledged that the past will be the first person responsible in the good and in the bad. As the first person responsible, he also is the first in authority, under the authority given him by the congregation. Protection of the church members, and accepted by the attending congregation on Sunday, January 30th time 11:55 am of the year 2000 at its location: 5859 South West 16 Street, Dade County. Miami, Florida 33155.

In the presence of more than three quarters of the "Iglesia Bautista Redención's" active church members, as explained in the ARTICLE XVII, Amendments to the Articles of Incorporation shall be approved and submitted to the members for ratification at a special meeting called for those purposes. The ratification of any amendment shall require three-fourths (3/4) vote of those present at such special meeting. By the 3/4 active members presently of the congregation, the following points were addressed by Pastor Tomas Diaz and were approved by 3/4 active member presently of the congregation:

POINT I). - The church members were informed about the fairness of the number of votes presently required to make the Church's Pastor cease immediately on his pastoral functions: ARTICLE XII - Destitution of the pastor. If the pastor in the course of his functions is rejected or repudiated by 30% of the active members of the church, he should resign from his function as pastor. In the event, he does not resign he shall be considered by the church destitute.

ARTICLE XII, AMENDMET TO THE ARTICLE OF INCORPORATION APPROVED AND AMENDED.

Destitution of the pastor. If the pastor in the course of his functions is rejected or repudiated by 51% of the active members of the church, he should resign from his function as pastor. In the event, he does not resign the shall be considered by the church destitute.

POINT II). - Consequently, it was proposed to increase the actual number of votes from the present 30% to a 51%. Therefore, as of the date of this meeting, a 51% of votes majority will be required to execute any action as referred on Point I herein.

POINT III). - The points above proposed were accepted 3/4 active members presently of the congregation. Therefore, these amendments shall become effective immediately.


After democratically discussed and voted on the previous proposed points, the following agreement was reached:


AGREEMENT: Effective Sunday, January 30th of the year 2000, the amount of votes required by the Iglesia Bautista Redencion to make the active Pastor cease on his pastoral functions will be of 51%. This agreement supersedes and annuls any previous agreement or percentage previously stated.


The meeting was unanimously adjourned on Sunday, January 30th of the year 2000 at 12:50pm in the afternoon.

From 30% to 51% in all places where the 30% was established within this ARTICLE.
