AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

LEMON BAY ISLES PHASE 3/4 PROPERTY OWNERS' ASSOCIATION

A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE I

NAME

The name of this corporation is LEMON BAY ISLES PHASE 3-4 PROPERTY OWNERS' ASSOCIATION, INC. Hereinafter it may be referred to interchangeably as the corporation or association.

ARTICLE II

NOT FOR PROFIT

This corporation is organized pursuant to the Corporation Not for Profit Law of the State of Florida, as set forth in Part One of Chapter 617 of the Florida Statutes. Funds raised by this corporation may be used only for the purposes set forth below. In no case shall earnings of the corporation be used to benefit any individual member, director or officer.

ARTICLE III

PURPOSES

The purposes for which this association is organized are to advance the interests of the property owners and residents in Lemon Bay Isles, Phase 3-4 by owning, maintaining and operating real and personal property for the benefit of the subdivision, enforcing the restrictions for the subdivision, and to improve the subdivision in any way it determines to be appropriate.

ARTICLE IV

POWERS

In addition to powers conferred by Statute, the association shall have the power to solicit and accept gifts of money and property of any kind for carrying out the purposes of the corporation. This corporation is empowered to buy and sell real estate, borrow and lend monies, enter into contracts, own real and personal property, lease property, and to do any act authorized under the laws of the State of Florida for corporations not for profit.

ARTICLE V

MEMBERSHIP

The membership of this association shall consist of all property owners in Lemon Bay Isles Phase 3-4.

Membership shall be appurtenant to the lot owned by the original property owner approved for membership and may not be transferred to any other person other than the owner of the lot to which the membership is appurtenant. Whenever ownership of a lot (having a membership appurtenant thereto) is transferred, the membership in this association shall automatically transfer to the new lot owner. Upon being supplied with satisfactory proof of the change in lot ownership, the association's officers shall change the membership roll.

ARTICLE VI

MANAGEMENT OF CORPORATE AFFAIRS

The affairs of the corporation are to be managed by the Board of Directors of not less than three (3) or more than nine (9) directors, who must be members. The assets of the corporation shall be controlled by the Board of Directors, and it shall exercise the powers of the corporation, except to the extent properly delegated to the elected officers.

The Directors shall be elected by the members at the annual membership meeting in accordance with the Bylaws.

The Board of Directors shall establish the amount and terms of payment of any dues and/or assessments for the operation, maintenance or acquisition of property, provided however, that there shall not be any assessment made or dues charged with respect to lots which have never been sold.

ARTICLE VII

OFFICERS

All officers shall be elected by the directors of the corporation following the annual membership meeting, which will be held at a time and place specified in the Bylaws.

The offices of secretary and treasurer may be combined if the corporation so elects. Other officers may be established by the Board of Directors. Officers must be members of the association. Their qualifications, duties and terms of office shall be as set forth in the Bylaws.

ARTICLE VIII

BYLAWS

The Bylaws of the association shall be adopted by a meeting of the Board of Directors at which a quorum is present. Thereafter the Bylaws may be amended with the approval of a majority of the members present at a duly called meeting of the membership, at which a quorum is present.

ARTICLE IX

AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended with the approval of a majority of the members present at a duly called meeting of the membership at which a quorum is present. Such amendments shall take effect when filed with and approved by the Secretary of State, and when filed in the corporate minute book.

ARTICLE X

EXISTENCE

This corporation shall have perpetual existence unless dissolved according to law.

ARTICLE XI

QUORUM AND NUMBER OF VOTES

A quorum for the official meetings of the members and for the Board of Directors shall be the number provided for in the Bylaws of the corporation.

Each member shall have as many votes as it owns lots which qualify for membership under Article V.

BASIC BACKGROUND

OF

Lemon Bay Isles Phase 3-4 Property Owners' Assoc., Inc.
A Florida Corporation Not For Profit

The Developer, Lemon Bay Isles, Inc, filed the original Articles of Incorporation in 1989 for Lemon Bay Isles 3 Property Owners' Assoc., Inc., A Florida Corporation Not For Profit. Lemon Bay Isles 4 Property Owners' Assoc., Inc., A Florida Corporation Not For Profit was developed later. In 1999, LBI 3 POA and LBI 4 POA merged to form Lemon Bay Isles Phase 3-4 Property Owners' Assoc., Inc., A Florida Corporation Not For Profit.

While the Developer owned lots and had voting rights the Articles of Incorporation and the By-laws remained un-amended. The Developer no longer owns property in the subdivisions of LBI 3 and 4. We are amending the Articles of Incorporation to bring them up to date.
