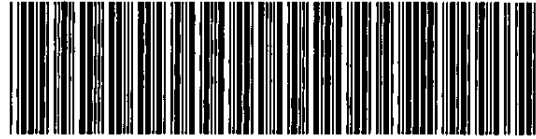

NAME


The name of the corporation shall be:

SPORTSMEN FOR BETTER HEALTH, INC.


