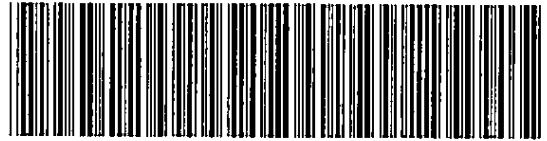

The Bylaws of the corporation may be adopted, altered, amended or repealed by the membership in the manner provided in the Bylaws, or by the Directors, if specifically authorized by statute or the Bylaws.

New Article XI shall be added as follows:

The Articles of Incorporation of the Corporation may be amended by the affirmative vote of a two-thirds majority of the members present or represented by proxy at any regular or special meeting called for that purpose.
