Addendum

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RIVERSIDE VOA ELDERLY HOUSING, INC.

(the "Corporation")

The Articles of Incorporation of the Corporation are amended as follows:

ARTICLE VI, first paragraph, is amended as follows:

<u>Delete</u> the following language from the first sentence of the first paragraph:

"and shall be elected by the Member of the corporation"

ARTICLE VI, second paragraph is amended to read as follows:

"ARTICLE VI

The Corporation will not have members. The affairs of the corporation shall be managed by a board of directors, consisting of not less than seven nor more than fifteen directors. The directors of the corporation shall, at all times, be limited to individuals who are either members of Volunteers of America, Inc. or nonmembers who have the approval of the Board of Directors of Volunteers of America, Inc. In the event that a director of the corporation ceases to be a member of Volunteers of America, Inc., or if the aforesaid approval is withdrawn, then in either event, such shall constitute automatic resignation as a director of the corporation."
