
Dear Sir or Madame:

Due to the hurricanes hitting this area and the significant destruction caused in our subdivision, the records from our POA, residing in the home of our treasurer Ms. Callie McMunigal, were buried under debris as was the rest of the interior of her home for almost a year. It has only been recently that she was able to move back into the house, extricate the records, and attempt to determine what had occurred. Unfortunately, shortly after moving back, her home was again damaged by hurricane Wilma. Fortunately, at least for our subdivision, our records are kept in a watertight safe and suffered no damage. In the same period, my home also sustained significant damage (in addition to having a death in the family) and I was only recently able to follow up on what had happened. Ms. McMunigal's records do show that a check and the application were made out before the hurricanes, but we cannot verify precisely what happened after that.

Since the chaotic situation that prevailed precludes us from verifying what actually happened, I am submitting a **2005 Not-For-Profit Corporation Reinstatement Form** for the **South Moon Under Property Owners Association**. Also, pursuant to a phone conversation between your agency and Ms. McMunigal a few weeks ago, in which it was agreed to waive the penalty fee because of the extenuating circumstances, I am enclosing a check in the amount of \$61.25, the standard fee.
