TO
ARTICLES OF INCORPORATION OF**

TAMPA PALMS UNIT 4B OWNER'S ASSOCIATION, INC.

Article I amended as follows.

The name of the corporation is **THE SANCTUARY AT TAMPA PALMS HOMEOWNERS ASSOCIATION, INC.** ~~TAMPA PALMS UNIT 4B OWNERS ASSOCIATION INC.,~~

Article II amended as follows.

This corporation does not contemplate pecuniary gain or profit, direct or indirect to its Members, and its primary purposes are:

A. To promote the health, safety and, social welfare of the owners of all Lots located within ~~Tampa Palms Unit 4B~~ **The Sanctuary at Tampa Palms** (the "Community"), a platted subdivision within Tampa Palms, a master planned community within Hillsborough County, Florida;

B. To maintain all portions of the Community and improvements thereon for which the obligation to maintain and repair has been delegated to the corporation by the Declaration of Covenants, Conditions and Restrictions of ~~Tampa Palms Unit 4B~~ **The Sanctuary at Tampa Palms** ("Declaration") which is to be recorded in the public records of Hillsborough County, Florida;

C. To carry out all of the duties and obligations assigned to it, if any, as a community association under the Declaration of Covenants, Conditions and Restrictions of Tampa Palms.

Article IX amended as follows.

ARTICLE IX

Voting Rights. The Association shall have ~~two (2)~~ **one** classes of membership, Class "A" ~~and Class "B"~~, as follows:

1. Class "A". Class "A" Members shall be all Owners ~~with the exception of Related Homes of Tampa, Inc., a Florida corporation ("Declarant").~~ Class "A" Members shall be entitled to one (1) equal vote for each Lot owned in the Community. When more than one (1) person holds an ownership interest in any Lot, all such persons shall be Members and the vote for such Lot shall be exercised as those Owners themselves determine and advise the Secretary prior to any meeting.

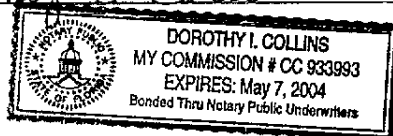
