

ARTICLES OF AMENDMENT TO



ARTICLES OF INCORPORATION FIRST BAPTIST CHURCH OF GOLDEN GATE, INC. TALLAHASSEE, ELORING

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For LORIDA Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

Article IV, section A., is amended as follows:

3. The board of Trustees shall have no power to sell, buy, mortgage, lease or transfer any property without a specific vote of the majority of active members present at a meeting called for that purpose authorizing such action, but unless otherwise provided, said Trustees shall have full management authority over the day to day operations of the church, including affixing their signatures to legal documents involving the sale, purchase, mortgaging or renting property or other legal documents where the signatures of the Trustees are required.

Article IX shall be amended as follows:

AMENDMENT OF ARTICLES AND AMENDMENT OF BY-LAWS

Except as otherwise provided for by Florida law, these Articles of Incorporation may be amended by a majority vote of the voting interest at any annual or special meeting, or by approval in writing of a majority of the active members without a meeting, provided that notice of any proposed amendment has been given to the active members, and that the notice contains a copy of the proposed amendment. An amendment shall become effective upon filing with the Secretary of State and recording a certified copy in the Public Records of Collier County, Florida.
