ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

BRADFORD ECUMENICAL MINISTRIES, INC. AMENDED TO

BRADFORD FOOD PANTRY, Inc.

(a religious nonprofit corporation)

The undersigned, having associated ourselves together under and by virtue of the laws of the State of Florida, hereby adopt these Articles of Incorporation t be legally binding as of the date of filing with the state.

ARTICLE 1. Name and Principal Place of Business. The name of the corporation is Bradford Food Pantry, Inc., a religious nonprofit corporation. Its principal place of business is Bradford County and its surrounding areas.

ARTICLE 2. Statement of Faith. We Believe in the Bible as originally given by God, divinely inspired, infallible, entirely trustworthy; and the supreme authority in all matters of faith and conduct.

One God eternally existent in three persons, Father, Son, and Holy Spirit.

Jesus Christ God manifest in the flesh, His virgin birth, His sinless human life, His divine miracles, His atoning death, His bodily resurrection, and His Personal return in power and glory.

Salvation of lost and sinful man through the blood shed by Jesus Christ by faith apart from works, and regeneration by the Holy Spirit.

Holy Spirit by whose indwelling the believer is enabled to live a holy life, to witness and work for the Lord Jesus Christ.

Unity of the Spirit of all true believers as the body of Christ.

ARTICLE 3. Purpose and Organization

- 3.1. Purpose: This Corporation is organized, and at all times shall be operated exclusively as a "Charitable Organization, for charitable, religious, educational and scientific purposes within the meaning of Section 501(c)(3) under the applicable provisions of the United States Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law) and its regulations (as they now exist or may hereafter be amended) (collectively, the "Code"). Any activity which is inconsistent with the designation as a Charitable Organization is prohibited and is void ab initio.
- **3.2.** Organization: This Organization is to coordinate with area churches and religious groups for the purpose of aiding the needy and homeless of North Central Florida.

3.3. The advancement of religion, charity, education and other related or corresponding purposes of aiding the needy and homeless.

ARTICLE 4. Members.

- **4.1.** Preferably two or more representatives, in good standing, from each supporting church will serve as the members of the Bradford Food Pantry, Inc.
- **4.2.** A letter of "Good Standing" shall be given to the board as membership into the Bradford Food Pantry.

ARTICLE 5. Board of Directors.

5.1. Shall be chosen from the Members of Bradford Food Pantry, Inc.. The Board of Directors shall be composed of, but not limited to, these offices as described in the ByLaws.

- **5.2.** The powers of the Bradford Food Pantry, Inc. shall be exercised, its properties controlled, and its affairs conducted by a Board of directors. There shal be no term limit on these offices.
- **ARTICLE 6. Limitation of Liability.** To the fullest extent that the law of the Sta of Florida, as it now exists or as it may hereafter be amended, that an individuals action be held against the Bradford Food Pantry, Inc. members or Board of Directors.
- **ARTICLE 7. Distribution of Assets.** In the event of dissolution of the Bradford Food Pantry, Inc. the Board of Directors. liquidate and distribute its assets to supporting churches as it sees fit.
- **ARTICLE 8. Directors.** The Bylaws shall specify the number and role of Directors.
