AMENDED AND RESTATED ARTICLES OF INCORPORATION OF HAMMOCK DUNES CLUB, INC.

(A Not-For-Profit Corporation)
January 1, 2012

The Articles of Incorporation of Hammock Dunes Club, Inc., a not-for-profit corporation, are hereby annually and restated as follows, pursuant to a Resolution of the Board of Governors adopted as of December 13, 2011. These Amended and Restated Articles of Incorporation and any amendments included herein have been duly adopted by the Board of Governors as of the date hereof and there is no discrepancy between the articles of incorporation and the provisions of these Amended and Restated Articles of Incorporation other than the inclusion of amendments adopted and the omission of matters of historical interest.

ARTICLE I

The name of the Corporation shall be "HAMMOCK DUNES CLUB, INC." (hereinafter referred to as the "Club"). Its principal office shall be at 30 Avenue Royale, Palm Coast, Florida 32137, or at such other place as may be designated, from time to time, by the Board of Governors.

ARTICLE II DURATION

The period of duration of the Club is perpetual.

ARTICLE III PURPOSE AND POWERS

The sole purpose of the Club is to own and operate a private and social club for the pleasure and recreation of its members, their families and their guests. The Club is organized exclusively for pleasure, recreation and other nonprofitable purposes. The Club shall be enquiwered to acquire, rent, lease, let, hold, own, buy, convey, mortgage, bond, sell or assign property, real, personal or mixed, and to borrow money, whether secured or unsecured, and to do and perform all such other acts and things as are allowed by the laws of the State of Florida with respect to not-for-profit corporations, as those laws now exist or as they may hereafter provide.

ARTICLE IV PROMIBITION AGAINST DISTRIBUTION OF INCOME

The Club is one which does not permit pecuniary gain or profit. No part of any net earnings shall inure to the benefit of any member, governor or officer, and as such they will have no interest in or title to any of the property or assets of the Club. Nothing herein shall prohibit the Club from

reinflurning its governors and officers for all expenses reasonably incurred in performing services rendered to the Club.

ARTICLE V CAPITAL STOCK

The Club shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE VI QUALIFICATIONS OF MEMBERSHIP

The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the Amended and Restated By-Laws of the Club.

ARTICLE VII VOTING RIGHTS

Members of the Club will have such voting rights as are provided in the Amended and Restated by-Laws of the Club.

ARTICLE VIII LIABILITY FOR DEBTS

Neither the members nor the officers or governors of the Club shall be liable for the debts of the Club.

ARTICLE IX BOARD OF GOVERNORS

The Board of Governors shall be elected by the equity members of the Club. The Board of Governors of the Club shall have such number and terms as specified in the Amended and Restated By-Laws of the Club. The names and addresses of the current governors of the Club are:
