ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

FLORIDA STATE BOWLING ASSOCIATION, INC.  
(a corporation not for profit)

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE 1. NAME.

The name of the corporation shall be Florida State Bowling Association, Inc. The principal place of business of the corporation shall be 4607 Havre Way, Pensacola, Florida 32505.

ARTICLE 11. PERIOD OF EXISTENCE.

This corporation shall have a perpetual existence unless lawfully dissolved.

ARTICLE 111. PURPOSE AND OBJECTIVES.

The purpose and objectives of this corporation shall be: In furtherance of the foregoing objects, this association shall be conducted as a nonprofit organization, organized and operated at all times exclusively for charitable and educational purposes and, particularly, to foster regional, national and international bowling competition either directly or by contributions to organizations that are recognized as exempt from federal income taxation as organizations described in section 501 (c) (3) of the Internal Revenue Code of 1986, as amended. In furtherance of the foregoing purposes, this association shall be organized and operated primarily to conduct or support bowling competition and to support or develop amateur bowling athletes for national or international competition within the meaning of section 501 (J)(2) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV. MEMBERSHIP AND ADMISSION

A. The membership of this organization shall consist of all local association members in Florida of the male sex in good standing with the American Bowling Congress.

B. For representative purposes, the State of Florida will be divided into four (4) zones containing the Guantanamo Bay Naval Base in Cuba and the counties of Florida as follows:

North Zone: Escambia, Santa Rosa, Okaloosa, Walton, Holmes, Jackson, Washington, Bay, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon, Wakulla, Jefferson, Madison, Taylor, Hamilton, Suwanee, Lafayette, Dixie, Columbia, Gilchrist, Levy, Baker, Union, Bradford, Alachua, Nassau, Duval, Clay, Putnam, St. Johns, Flagler, and Martin.

East Zone: Volusia, Sumter, Lake, Seminole, Orange, Brevard, Osceola, Indian River, Okeechobee, St. Lucie, and Martin.

West Zone: Citrus, Hernando, Pasco, Pinellas, Hillsborough, Polk, Manatee, Hardee, Highlands, Sarasota, DeSoto, Charlotte, Glades, Lee, Hendry, and Collier.

South Zone: Dade, Monroe, Broward, Palm Beach, and Guantanamo Bay Naval Base.

C. The method by which each member shall be admitted shall be regulated by the by-laws of the corporation.

#### ARTICLE V. OFFICERS AND DIRECTORS.

The corporation shall have a president, four vice-presidents (one from each zone), a secretary-treasurer and a sergeant at arms. The Board of Directors shall be composed of the officers as well as one director from each of the four zones as well as the four immediate past presidents. ARTICLE VIII. A NON-STOCK CORPORATION.

This corporation is organized under a non-stock basis. There are no members or members entitled to vote.

ARTICLE IX. DISSOLUTION.

In the event that the Corporation shall be liquidated and dissolved, all of its assets remaining after payment and discharge of its duties, obligations and liabilities shall be distributed, in such proportion as the Board of Directors shall determine, to any organization or organizations, including trusts, organized and operated exclusively for charitable and educational purposes, provided that no portion of the assets shall be distributed to any organization that is not described in section 501 (C)(3) of the Internal Revenue Code of 1986, as amended. Any such assets not so disposed of shall be disposed of by the Circuit Court in which the principal office of the Corporation is then located, exclusively for the purposes described in section 501 (C)(3) of the Internal Revenue Code of 1986, as amended, or to such organization or organizations as said Court shall determine are organized and operated exclusively for such purposes.

These Articles of Amendment were adopted by the Directors on October 11, 1997.
