Additional Amendments and Changes for CHERA INC Document Number N31516

Article VI, Section 2(A) is amended to read as follows:

The President shall preside at all meetings, regular or special, of the Board of Directors, the Advisory Board, and the CHERA Residents Meetings. Furthermore, the President shall perform any other duties as stated in the Policies and Procedures Manual.

Article VI, Section 2(G) is amended to read as follows:

The Parliamentarian will inform and advise the Board about parliamentary issues. If an issue is not addressed in CHERA's Articles of Incorporation, its Bylaws, or the Policies and Procedures Manual, the Parliamentarian will refer to Robert's Rules of Order as a guideline.

Article VII, is amended to read as follows:

Committees are divided into two categories, the first being Standing Committees, the second, Ad Hoc Committees. Standing committees are those created by the current President of CHERA, who reports committee member names to the CHERA Board. Ad Hoc Committees are those Committees which have arisen as a result of a specific need and report to the CHERA Board. The President can create a new Committee when he/she determines it desirable. The President can, subject to Board approval, remove or change the category of any Committee. The Committee Members, with the exception of the Nominating-Committee, shall select the Chairperson of their Committee with the approval of the President. If no Chairperson is chosen by the Committee, The President may do so. New members can be added by the Chairperson. The President, with the approval of the Board, has the authority to remove a Committee Chairperson.

Article VII, Section 1(A) is amended to read as follows:

The current Vice President of CHERA shall appoint the Chairperson of the Nominating Committee, be a voting member of the Committee, and shall be familiar with the proceedings of the Committee. The Chairperson shall appoint no more than 4 additional residents to serve on the Committee.

Additional Amendments and Changes for CHERA INC Document Number N31516

Article VII, Section 1(A)(1)(b)(1) is amended to read as follows:

Residency of at least one year is beneficial.

Article VII, Section 1(A)(1)(b)(2) is added and shall read as follows:

Previous position specific background should be considered.

Article VII, Section 1(B) is amended to read as follows:

With the exception of the Nominating Committee, the newly elected President will, no later than May 15th, announce at a quarterly meeting and publish to all Board members a list of Committee Chairpersons for all Standing Committees.

Article VII, Section 1(C) is amended to read as follows:

Committee Chairpersons may select additional members for their Committee throughout the year. Any resident may volunteer or request membership on any Committee. If there is an opening on the Committee, the Chairperson may add the person to his/her Committee and notify the President to update the master list.

Article VII, Section 1(D) is deleted.

Article VII, Section 2 is deleted.

Article VII, Section 3 is renumbered as Section 2

Article VII, Section 4 is renumbered as Section 3

Article VII, Section 3(B) is amended to read as follows:

Committee Chairpersons submit a report monthly to the President and Secretary and give oral reports at the Quarterly Residents Meeting.

Additional Amendments and Changes for CHERA INC Document Number N31516

Article VIII, Section 1 is amended to read as follows:

There shall be four (4) CHERA meetings of the Residents per year on the Second Thursday in March, June, September and December. The meeting can be held on an alternate date at the discretion of the President. Notification must be given to all residents five (5) days in advance.

Article VIII, Section 3 title is changed to "Advisory Board Meetings" and is amended to read as follows:

Advisory Board Meetings shall be called by the President or by a quorum of the Board of Directors. Notice shall be given to all Committee Members at least three (3) days prior to the meeting date.

Article VIII, Section 5 is amended to read as follows:

The President may call a Special Meeting of the Residents, but in each instance the only matters that may be considered, are those specified in a notice at least three (3) days prior to such Special meeting.

Article VIII, Section 7 is added, the title which shall read "Resident Issues (Residents)", and shall read as follows:

Residents may submit an issue for board consideration during a regularly scheduled resident's meeting or in writing to the President at anytime or five (5) days prior to the Quarterly Meeting. If an issue submitted in writing can be fully addressed to the satisfaction of the board, it may be voted upon by the Board, if so required. That issue will be considered as resolved and duly recorded in the meeting minutes. The Board retains the right to defer discussion of the issue to the next Advisory Board meeting and if required, prepare to vote on the issue at the next regular residents meeting. That issue and vote will be recorded in the meeting minutes.

Article XI is amended to read as follows:

Any parliamentary procedure not covered by these Bylaws shall be guided by Robert's Rules of Order.
