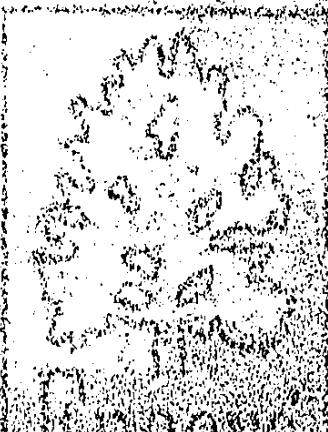

**Articles of Amendment
to
Amended and Restated Articles of Incorporation
of
Fort Lauderdale Sister Cities International, Inc.**

Fort Lauderdale Sister Cities International, Inc. was formerly known as People to People International of Ft. Lauderdale, Inc.. The Amended and Restated Articles of Incorporation filed by People to People International of Ft. Lauderdale, Inc. on July 19, 1990 changed the name of the corporation to Fort Lauderdale Sister Cities International, Inc.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

Article I of the Amended and Restated Articles of Incorporation filed by People to People International of Ft. Lauderdale, Inc. on July 19, 1990 changing the name of the corporation to Fort Lauderdale Sister Cities International, Inc. is hereby amended and shall read:

ARTICLE I NAME

The name of this corporation shall be: FORT LAUDERDALE - GREATER - SISTER CITIES INTERNATIONAL, INC.
