## Gentlemen:

The purpose of this letter is to request that the reinstatement fee of \$175 be waived for Community Faith In Action, Inc. As I explained in my telephone call to your office, we did not receive either the first or second notice. I believe the problem occured as a result of an incorrect mail delivery. In block "1", our mailing address is shown as both 1100 15th St. E along with our P.O. Box 2108 number. The physical facility at 1100 15th St. E. is the Rogers Memorial United Methodist Church and it does not have a mail box. The church has a POB at which it receives mail. In the past, the regular postman knows to leave mail addressed to 1100 15th St. E at the church parsonnage which is next door to the church or he leaves it at the home of a church member which lives nearby. In either case, mail left at either place is often lost, misplaced, or simply never gets to the proper party. This has been an ongoing problem when mail is sent to the 1100 15th St. E. address rather than to the POB. In Box "3" of the application for reinstatement, I have corrected what I believe caused the problem by showing our mailing address as strictly POB 2108.

On behalf of Community Faith In Action, Inc., I want to thank you for your consideration of this appeal to waive the \$175 fee for reinstatement.
