University of South Florida Medical Services Support Corporation was originally incorporated on May 9, 1993 pursuant to the Florida Not For Profit Corporation Act, and filed Amended and Restated Articles of Incorporation on March 15, 2017.

In accordance with Sections 617,1002 and 617,1006 of the Florida Not For Profit Corporation Act and pursuant to a resolution duly adopted by an affirmative vote of two-thirds (2/3) of the corporation's Directors on June 5, 2019, University of South Florida Medical Services Support Corporation hereby adopts the following First Amendment to the Amended and Restated Articles of Incorporation of the corporation. There are no members entitled to vote on the Amendment.

It is resolved that the following sentence is added to the end of Article IV, Section 1:

Except as set forth in Article IV, Section 1. B and Article IV, Section 1. C., all other Directors shall be approved by the USF Board of Trustees.
