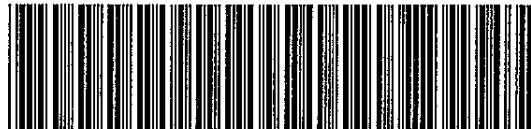

Re: Rescind Last 2 Amendments
Made To Our Articles of Incorporation

To Whom This May Concern;

We, the Legistrative Board for Grace Ministry of Faith Church, are hereby repealing the last 2 Amendments made by Rev. Carlton J. Radcliffe to our Articles of Incorporation .

In December of 2002, our Boad hired Rev. Radcliffe, as pastor, to carry out Religious Duties for our Ministry. Subsequently, the Reverend has violated our trust, and the Bylaws of our Corporation, by taking it upon himself to go behind our backs and illegally tamper with Executive Documents for personal gain. Article #3 of our Corporation states that, "A mature person who acknowledges Jesus Christ as his Lord and Savior, and is willing to work...may, upon request, be admitted to membership by vote of a majority of the Board Members." Please be advised that the amendments transacted in Article #3 by Rev. Radcliffe, stamped and filed in your office on Aug . 8, 2003 @ 12:57 P. M., are in direct violation of our Bylaws. Our Board had no knowledge of names being added or deleted by the Reverend. New people were never presented to the Board of Directors to be voted in as members, nor did a vote take place to delete any names from the Articles of our Corporation, or to appoint Rev. Radcliffe as Head C.E.O for Grace Ministry of Faith Church, Inc.

As a result of him being able to illegally transact forestated amendments through your office, he has seized our property, locked us out of our own church that the Lord gave in 1987, put new locks on the church doors, and mailbox. He then took the Amended Articles to the bank where our church has done business for over 15-years, and stole \$10,000.00 of which we knew nothing about. He placed this money into a new account, subsequently, all of the accounts are frozen, and the church is standing still.

Please be advised that on October 15, 2003, we the orginal Board of Directors of Grace Ministry of Faith met with our Lawyer and an Official from the County Court House in Fort Myers, Fla., Tammy E. Betz, a Registered Professional Reporter, and Notary Public for the state of Florida, where we officially voted Rev. Radcliffe out of office as our pastor. (See Attached)

This letter is a request by the original Board, Director Henry Sullivan, Dorothy Sweet and Vice Director, Horace Sweet, for an abandonment of all amendments transacted by Rev. Radcliffe, and that our original Articles be restored and mailed to Grace Ministry of Faith, in care of Director Dorothy Sweet, @ 2637 Orange Street, Ft. Myers, Florida 33916.

We thank you in advance for your cooperation in helping us to correct all the wrong that has been done in the work of the Lord. Since the wrong was done through your office, we believe with full assurance that you all will see that this matter is corrected, because you are for the good of the people.




