AMENDMENT TO ARTICLE X.A OF THE ARTICLES OF INCORPORATION FOR SUMMER CHASE HOMEOWNERS ASSOCIATION, INC.

A.—Subsequent to the resignation of the remaining developer appointed Board member, or earlier if agreed in writing by the Developer, the <u>The</u> number of directors shall be expanded to not less than five (5) or and not more than seven (7); the number to be fixed <u>at the Annual Election Meeting each year</u>. If there are six (6) or fewer candidates, the Board will consist of five (5) Directors, but if there are more than six (6) candidates the Board shall consist of seven (7) Directors, by the then serving Board. If this event should occur before August 1<sup>st</sup>, the additional Directors are to be nominated and elected according to the procedures set forth in the documents.
