PLAN OF MERGER OF OKEECHOBEE EDUCATIONAL FOUNDATION, INC., AND THE CHARLES McARTHUR FOUNDATION, INC.

This is a Plan of Merger between OKEECHOBEE EDUCATIONAL FOUNDATION, INC., a Florida corporation, and THE CHARLES McARTHUR FOUNDATION, INC., a Florida corporation.

ARTICLE I Constituent Business Entities

The names of each constituent business entity are:

OKEECHOBEE EDUCATIONAL FOUNDATION, INC., and THE CHARLES MCARTHUR FOUNDATION, INC.

ARTICLE II Merger

Pursuant to sections 607.1101 and 607.1103, Florida Statutes, THE CHARLES McARTHUR FOUNDATION, INC., shall be merged into OKEECHOBEE EDUCATIONAL FOUNDATION, INC.

ARTICLE III Surviving Business Entity

ARTICLE IV <u>Articles Of Incorporation and By-Laws of Surviving Business Entity</u>

The articles of incorporation and by-laws of OKEECHOBEE EDUCATIONAL FOUNDATION, INC., in effect immediately prior to the merger, shall not be changed by the merger and shall continue to be its articles of incorporation and by-laws subsequent to the merger.

ARTICLE V Officers, Directors and Members of Surviving Business Entity

- 1. The officers and directors of OKEECHOBEE EDUCATIONAL FOUNDATION, INC., immediately prior to the merger shall continue to be the officers and directors immediately following the merger. The officers and directors of THE CHARLES MCARTHUR FOUNDATION, INC., shall resign from their respective positions.
- 2. Neither OKEECHOBEE EDUCATIONAL FOUNDATION, INC., nor THE CHARLES McARTHUR FOUNDATION, INC., has any members.

ARTICLE VI Assets and Liabilities

- A. On the effective date of the merger:
- 1. The separate existence of THE CHARLES McARTHUR FOUNDATION, INC., shall cease and OKEECHOBEE EDUCATIONAL FOUNDATION, INC., shall, without further action, possess all of the rights and privileges of THE CHARLES McARTHUR FOUNDATION, INC., existing immediately preceding the merger; and
- 2. All assets of any nature of THE CHARLES McARTHUR FOUNDATION, INC., shall, without further action, be vested in OKEECHOBEE EDUCATIONAL FOUNDATION, INC., immediately following the merger.
 - B. Following the merger:
- 1. OKEECHOBEE EDUCATIONAL FOUNDATION, INC., shall be responsible for all liabilities and obligations of THE CHARLES McARTHUR FOUNDATION, INC.
- 2. Any claim existing or action or proceeding pending against THE CHARLES McARTHUR FOUNDATION, INC., may be continued as if the merger did not occur or OKEECHOBEE EDUCATIONAL FOUNDATION, INC., may be substituted for THE CHARLES McARTHUR FOUNDATION, INC., in any such proceeding. Neither the rights of creditors of nor any liens upon the property of THE CHARLES McARTHUR FOUNDATION, INC., shall be impaired by the merger.
