I have just completed my 501 (c)(3) 990, Non-Profit Corporate Filing. My accountant informed me that I have not filed the 2002 Uniform Business Report.


I did not receive the 2002 Uniform Business Report Form in the mail. I am currently in Tennessee working my Market Food Store.
