OF THE LEVY COUNTY SCHOOLS FOUNDATION, INC.**


Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following Second Amendment to its Articles Of Incorporation.


**FIRST:** The following sentence is to be added to the end of Article IV of the

“The organization shall operate in a non-direct support organization status”.


**SECOND:** This Second Amendment was adopted by the Levy County Schools
