ARTICLES OF AMENDMENT
to
ARTICLES OF INCORPORATION
of

INDIGO LAKES BAPTIST CHURCH, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

In accordance with Article XII of the Articles of Incorporation of INDIGO LAKES BAPTIST CHURCH, INC., a Florida not for profit corporation; the Board of Trustees of said corporation has adopted a Resolution dated October 15, 2000, which Resolution has been adopted by a vote of two-thirds of a quorum of members of the said Corporation. The membership has approved the amendment by a sufficient number of votes sufficient for approval to approve the following:

1. That Article I of the Articles of Incorporation be amended to allow for the Corporation to change the name. That the Corporation shall hereby further be called **INDIGO COMMUNITY CHURCH, INC.**
2. That Article VIII, section B of the Articles of Incorporation be amended to change the name of the Registered Agent to Richard Copeland at 1131 Lakewood Park Drive, Daytona Beach, FL 32117
