CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SOUTHWOOD, BLOCK 3 AND

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF SOUTHWOOD, BLOCK 3 HOMEOWNERS ASSOCIATION, INC.

Mark 30 PHD 28 THIS CERTIFICATE OF AMENDMENT is executed this 27 day of March 2024, by Southwood, Block 3 Homeowners Association, Inc., a Florida not-for-profit corporation (hereinafter the "Association").

RECITALS

WHEREAS, the Association has been established for the operation of Southwood, Block 3 Homeowners Association, Inc., in accordance with the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Southwood, Block 3, that was recorded on June 3rd, 2021 at Instrument #2021103916 of the Public Records of Sarasota County, Florida ("the Declaration"); and the Amended and Restated Articles of Incorporation of Southwood, Block 3 Homeowners Association, Inc. that were recorded as Exhibit "B" to the Declaration ("the Articles of Incorporation"); and,

WHEREAS, the amendments to the Declaration and the Articles of Incorporation were submitted to the Members of the Association at the meeting of the Members held on January 18th. 2024 which Meeting was duly noticed in accordance with the Florida Statutes; and,

WHEREAS, the amendments to the Declaration and the Articles of Incorporation were approved by not less than two-thirds (2/3rds) of all Voting Members; and.

MOW THEREFORE, the Association does hereby state as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. All present and future Members of the Association shall be bound by the amendments to the Declaration and the Articles of Incorporation.

New language is indicated by <u>underlined</u> type. Deleted language is indicated by strikethrough type.

I. Amendments to the Declaration:

Section 5.1 of Article V of the Declaration is amended as follows:

Section 5.1 Common Expenses. The Common Expenses of the Association shall mean the following:

j. Any cost or expense related to bulk communication services for the Association, including but not limited to cable television, telecommunication services and internet services.

j.k. Any cost or expense as is reasonably or necessarily incurred by the Association in connection with its duties under the Homeowners' Association Act and/or the Association's governing documents.

II. Amendments to the Articles of Incorporation:

Section 3.1 of Article III of the Articles is amended as follows:

Section 3.1 Association Powers. The Association, by and through its Board of Directors ("Board"), shall have all of the statutory powers of a corporation not for profit and all of the powers and duties set forth in Florida law and the Declaration and Bylaws, including but not limited to the following:

(k) To agree to bulk communication services for the Association, including but not limited to cable television, telecommunication services and internet services.

All other Sections remain unchanged.
