CURRENT PROVISION:

ARTICLE 2 CORPORATE PURPOSE

This organization is organized exclusively for girls charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to the support of MANATEE COUNTY GIRLS CLUB INC., and exempt organization under Section 501(c) (3) of the Internal Revenue Code of the 1954 (or the corresponding provision of any future United States Internal Revenue Law). The duties and functions and purposes of this corporation shall be limited to those set forth in these articles and no other. Provided, however, in the event that MANATEE COUNTY GIRLS CLUB INC., the 501 (c) (3) organization, shall no longer qualify as a 501 (c) (3) organization, or the existence thereof shall terminate, then this organization shall devote its purposes, activities, and earnings to the support of such other 501 (c) (3) organizations whose purposes and objectives are similar to that of MANATEE COUNTY GIRLS CLUB, INC.

PROPOSED PROVISION:

ARTICLE 2 CORPORATE PURPOSE

This organization is organized exclusively for the purposes of promoting charitable, educational, scientific, social, moral, ethical, and health related services, programs, and facilities for the direct benefit and advancement of the general welfare of girls or adolescent females, including within such purposes, the financial support of and making of distributions to MANATEE COUNTY GIRLS CLUB, INC., an exempt organization under Section 501(c) (3) of the Internal Revenue Code of the 1954 (or the corresponding provision of any future United States Internal Revenue Law) and from time to time for the support of other tax exempt, charitable, not-for-profit organizations, which may be directly affiliated with the MANATEE COUNTY GIRLS CLUB, INC., and which promote the same or substantially the same purposes of the MANATEE COUNTY GIRLS CLUB, INC. such as JUST FOR GIRLS ACADEMY, INC., a Florida not-for-profit corporation.

The duties and functions and purposes of this corporation shall be limited to those set forth in these articles and no other. Provided, however, in the event that MANATEE COUNTY GIRLS CLUB, INC., the 501 (c) (3) organization, shall no longer qualify as a 501 (c) (3) organization, or the existence thereof shall terminate or otherwise cease to exist, or should MANATEE COUNTY GIRLS CLUB, INC. substantially change in its purposes and function so that it ceases to be an organization which exists primarily to promote charitable, educational, scientific, health, social, ethical, moral, and general welfare purposes of girls or adolescent females through primarily girls-only services, programs and facilities, then this organization shall devote its purposes, activities, and earnings to the support of such other 501 (c) (3) organizations, or charitable, not-for-profit organizations, whose purposes and objectives are primarily to promote charitable, educational, scientific, social, moral, ethical, health and general welfare purposes of girls or adolescent females through primarily girls-only services, programs and facilities.
