Pursuant to the provisions of Section 617.1006, Fla. Stat. CAMBRIDGE GREENS OF CITURS HILLS, FIRST ADDITION, PROPERTY OWNERS ASSOCIATION, INC. adopts the following amendments to its Articles of Incorporation.

1. Article V, Voting Rights, shall read in its entirety as follow:

ARTICLE V VOTING RIGHTS

- A. The owner of each residential lot shall have one (1) vote per residential lot owned.
- 2. Article VI, Meetings of Members, shall read in its entirety as follow:

ARTICLE VI MEETINGS OF MEMBERS

The Bylaws of the Association shall provide for an Annual Meeting of members and may make provisions for regular and special meetings of members other than the Annual Meeting. A quorum for the transaction of business at any meeting of the members shall exist if thirty percent (30%) of the total number of members in good standing shall be present at the meeting in person or by proxy. If the required quorum is not present another meeting may be called and the required quorum shall be fifteen percent (15%) of the total number of members in good standing.
