We, the undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statues, subscribe, acknowledge, adopt and file the following Articles of Incorporation, Constitution and By-Laws of such Corporation:

ARTICLE I.

The name of this Corporation shall be:
FRIENDSHIP MISSIONARY BAPTIST CHURCH OF LAKELAND, INC.

The principal place of Business of this Corporation shall be:
1501 North Lincoln Avenue, Lakeland Florida. 33805.

ARTICLE II.

The existence of this Corporation shall be PERPETUAL, unless dissolved according to Law.

ARTICLE III.

The exact purposes for which this Corporation is Organized, is to conduct in accordance with the Holy Bible for Religious Worship, Praise and Prayer to Our Holy Father in the Name of Jesus Christ, Our Savior. This Christian Corporation will Fellowship with other institutions connected therewith of a Religious, educational, and a charitable benevolent character to this end that our own Members and others may be Generally instructed and Guided concerning the Word of God and those Articles of Faith held among Baptist Churches and to advance Spiritual Growth, enlightenment, moral and personal purity among the Membership and the people of the Community in which we are located. We are here to aid in the spread of the Gospel of our Lord and Savior Jesus Christ, that who so ever believe in him (Jesus Christ) Shall not perish, but have everlasting eternal Life. This Corporation shall have the right as voted on by its Members, the Majority ruling, to purchase, to own, to hold, to sell, to lease, to mortgage and otherwise dispose of said property, both, real and personal as the Membership so directs, either positive or negative. This Religious Church Corporation shall establish a Bus Ministry which will provide Free transportation services to Church Members, their families and other Church attendees to the Church Services and Activities which are regularly conducted and carried on each week.

ARTICLE IV.

Every person who believes in repentance toward God, and Faith in Jesus Christ, as Lord and Savior of their Soul, and who is willing to confess Jesus publicly as Lord of Lords, King of Kings and to follow Him in Baptism by immersion, and to observe the ordinances of Christ, and to be governed by God's Laws, is Qualified and Eligible for Membership in this Corporation. The Manner of Admission to Membership in this Corporation Shall Be by Letter of dismission from any other Church, or Denomination, or from a Church of same Faith as this Corporation, or any person who has never had a Church home who desire to be Saved and receive the Lord Jesus as their Christ and Savior. All things being in Order upon a favorable Majority of the Membership, VOTING, and being PRESENT at any Meeting of this Church Corporation, said applicant(s) and all those here after ADMITTED to such Membership SHALL constitute the Membership of this CHURCH.

ARTICLE V.

The Business affairs of this Corporation shall be managed by a BOARD OF TRUSTEES such management is to be subject to the approval of the CHURCH and PASTOR, and this BOARD is to be composed of not less than Three (3) Trustees at all times, and no more than Ten (10) Maximum. This Board of Trustees shall be Elected from and by the Membership of this Corporation, and EACH ONE shall be Twenty-One Years of Age, or Older. The TERM OF OFFICE for any Trustee shall be ONE (1) Year, all Trustees are to be Elected Annually by the Membership of this Corporation at their ANNUAL YEARLY MEETING, and/or, each Trustee term of office may be for such length time, and their election, as the Membership of this Corporation decides and provide for in its By-Laws.

The Officers of this Corporation Board of Trustees are: President/Chairman, Vice President/Ch., Treasurer, and Secretary of the Church, ALL four (4) are the Board of Trustees officials, all under the President/Chairman, who is subject to the Church and Pastor. The Pastor is an Incorporator of this Corporation.

All Legal instruments of this Church Corporation shall be signed by said President, sealed with the Corporate official Seal, and attested by said Secretary, and/or, in such other manner as may be authorized in the By-Laws of this Church Corporation.

ARTICLE V.
