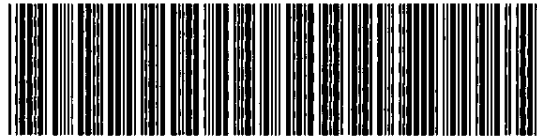

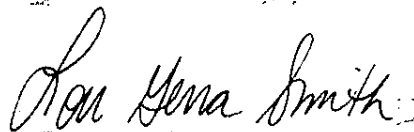

ARTICLE I

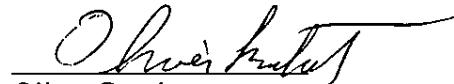
