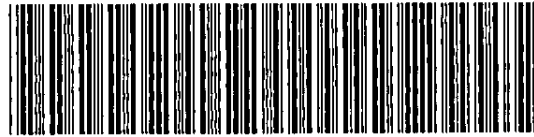

Article I. Corporate Name

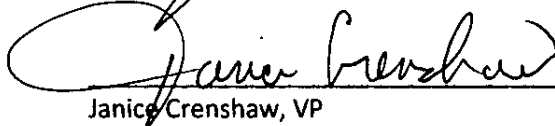
The Name of the Corporation is: Kingdom Life Worship, Inc.
