# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF METHODIST CHURCH TRUSTEES, JACKSONVILLE DISTRICT, UNCLASSEE, FLORID/

Pursuant to the provisions of Section 617.1006, Florida Statutes, and the original Articles of Incorporation, the undersigned corporation adopted the following amendments to its Articles of incorporation on November 18, 2001, by unanimous vote of the Members at the annual meeting of the membership:

1. Article I of the Articles of Incorporation is deleted, and the following is inserted in lieu thereof:

## ARTICLE I

## NAME

The name of this corporation is the Jacksonville District United Methodist Church, Inc. The principal address of the corporation is 1415 LaSalle Street, Jacksonville, Florida 32207-3113.

2. Article V of the Articles of Incorporation is deleted, and the following is inserted in lieu thereof:
