

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FOR NEW HOPE COMMUNITY CHURCH, INC.

Amendment to Articles of Incorporation of NEW HOPE COMMUNITY CHURCH, INC. a Not-for-Profit Corporation organized under the laws of the State of Florida, executed by Fred L. Coller, its President, and Coller, its Secretary.

- 1. The corporation was chartered on September 29, 1989 and assigned charter number N34458.
- 2. On June 20, 2000, the corporation, on proposal of its Board of Directors, by resolution duly adopted the proposed amendment. There are no members entitled to vote on the amendment.
