I. Amended Article III:

ARTICLE III:

The Corporation is organized exclusively for qualified social club purposes. The primary purpose for which the Corporation is organized shall be to act as a house corporation for and provide services to the Epsilon Omega Zeta Chapter (University of Miami, Florida) of Lambda Chi Alpha Fraternity. The Corporation may solicit and receive gifts, grants and other contributions, purchase, own, lease and sell real and personal property, make contracts, make gifts, grants and loans, borrow funds, invest funds and spend funds for corporate purposes, and engage in other activities in furtherance of, incidental to, or connected with any of the other purposes. No part of the net carnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the Corporation and to make payments and distributions in furtherance of the purposes set forth in this Article III. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income taxation under Section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

II. Amended Article VII:

ARTICLE VII:

Upon the dissolution of the Corporation, the assets of the Corporation, after paying or making provision for the payment of all debts and liabilities of the Corporation, shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) or Section 501(c)(7) of the Internal Revenue Code, or the corresponding section or sections of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for one or more exempt purposes within the meaning of Section 501(c)(3) or Section 501(c)(7) of the Internal Revenue Code, or the corresponding section or sections of any federal future tax code.
