The Southeast Pompano Homeowners Association (SEPHA) is a 700 home association with minimal annual revenues and a \$5,000 checking account balance. We were dissolved on 10/1/2004 for failing to file an Annual Report. Our document number with the State is N 34490.


The circumstances surrounding the dissolution as follows:

Our long time President John Hinman died in 2003. His mailing address was the address of record. We never received our annual report notices in the year of dissolution. The matter was further compounded with an interim President, who subsequently filed a change and moved from the area. Further adding to the disarray, we were hit with Hurricanes Francis and Jeanne in 2004 and Katrina and Wilma in 2005.

In January, 2006, I was elected the new President of SEPHA. I am attempting to set the ship right and start making repairs to our neighborhood necessitated by the hurricanes. Our cashflows are stretched to the limit. I am requesting a waiver of the reinstatement fee and including a check for \$61.25 times three totaling \$184.50, for the years 2004, 2005, and 2006. Also enclosed is the Corporate Reinstatement Application.
