ARTICLES OF AMENDMENT

comes now u.y.o scholarship fund of Gainesville, Florida, Inc. a corporation not-for-profit organized under the laws of the State of Florida and executes this Articles of Amendment in accordance with the provisions of Section 617.1006 of the Florida Statutes and states:

- 1. The name of the corporation is U.Y.O Scholarship Fund of Gainesville, Florida, Inc.
 - 2. The text of each amendment adopted is as follows:
- a. Article I of the Articles of Incorporation shall be amended to read as follows: Article I: The name of the corporation shall be Complementary Health Education Center, Inc.
- b. Article III of the Articles of Incorporation shall be amended to read as follows: Article III: The nature and purpose of the corporation is:
 - 1. To develop community based programs which support the health, functional status and habitation of families, individual members thereof and other persons in need of health and habitative services through the development, encouragement and promotion of community based programs, projects and services which reduce and/or delay the need for health care.
 - 2. To develop or establish other health care and education programs and services consistent with the purposes of the corporation.
 - 3. To promote purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) and the regulation pertaining thereto.
 - 4. To provide full or partial tuition to individuals who cannot afford tuition for a Dreikur's relationship center course. To do all things necessary or desirable to further purposes of the corporation.

c. Article V of the Articles of Incorporation shall be amended to read as follows: Article V: The number constituting the Board of Directors of the corporation shall be comprised of nine members, but shall not, in any event, be comprised of less than three members nor more than nineteen members. The names and addresses of the Board of Directors is as follows:

- d. The Articles of Incorporation are amended by addition of Article IX which shall read as follows: Article IX: Amendments to these Articles of Incorporation may be proposed and approved by a majority vote of the Board of Directors and the Bylaws of the corporation may be altered, amended or repealed by a majority vote of the Directors.
- 3. In accordance with the Bylaws of the corporation the amendment of these Articles shall be by majority vote of the Board

of Directors rather than a vote of the general membership and the date of the adoption of the above amendments by a unanimous vote of the Board of Directors was May 20, 1997 at a meeting held at 7:00 p.m. This unanimous vote constituted adoption of the above amendments by a majority vote of the Directors then in office at a meeting of the Board of Directors.
