



The administration shall not insert itself into the conduct of the affairs of any individual ~~condominium~~ association carried out pursuant to its own Articles of Incorporation, Bylaws and the appropriate statutes; however, the Federation Membership may approve assisting a member if requesting in writing to do so by said Member.
