Dear Ms. Cobb.

Please be advised we have no intention to dissolve our Corporation at this time. Our delay in renewing our Not for Profit status, is due to our not receiving the usual notice on a timely basis. Normally we receive it in February or March.

Please respond with your assurance that we have until September 6, 2006 to file our annual report with the designated fee. I will download the form from sunbiz.org immediately and get it filled out shortly.

We are presently working up our list of Officers and Directors, to be certain it is accurate. I am also awaiting a decision from our executive committee regarding the naming of our future registered agent.

We would further appreciate your confirming that our tax exempt status (Cert #18-00-024643-58C) which shows an expiration date of 2/27/07 can also be renewed. May we assume notification will be forthcoming for it? Note, the IRS has advised us that we do not have to file a 1024, as our income level is well below the \$25,000 annual level requiring it. With our membership now down to approximately 250 and our dues at \$6.00 annually, it is obvious we do not meet that requirement.
