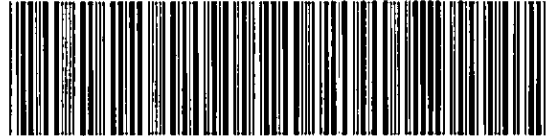



Amendment to Article 9, to read as follows:

ARTICLE 9

DIRECTORS

- 9.1 Number and Qualification. The property, business, and
affairs of the Association shall be managed by a board
(the "Board of Administration") consisting of the
number of Directors determined in the manner provided by the
Bylaws, but which shall consist of not less than three (3)
Directors. ~~Directors need not be Members of the~~
~~Association or residents of units in the Condominiums.~~
