Amendment to Article 9, to read as follows:

# ARTICLE 9

#### DIRECTORS

9.1 Number and Qualification. The property, business, and affairs of the Association shall be managed by a board (the "Board of Administration") consisting of the number of Directors determined in the manner provided by the Bylaws, but which shall consist of not less than three (3) Directors. Directors need not be Members of the Association or residents of Units in the Condominiums:

Directors shall be both Members of the Association and full time residents of units in the Condominiums.
