TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned nonprofit corporation has adopted the following Article of Amendment of its Articles of Incorporation as heretofore amended:

FIRST: Article One is amended by changing the name of the corporation to "THE NEW PEOPLES CHURCH, INC."

SECOND: The date of adoption of the amendment was September 16, 2000.

THIRD: The amendment was adopted by the members at a meeting duly noticed for that purpose, and the number of affirmative votes was sufficient for approval.

FOURTH: Rev. Chong Lee is appointed as Registered Agent For Service of Process. His address is 3655 Venice Ave. E., Venice, FL 34292.

FIFTH: This amendment does not change the status of this corporation as a constituent member of the General Assembly of the Korean American Presbyterian Church.
