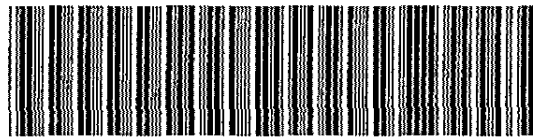

FOURTH: The date of adoption of these amendments is October 17, 2004.

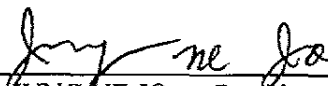
FIFTH: These amendments were adopted by unanimous vote of a quorum of the members of the corporation at a meeting duly noticed for these purposes.
