AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
AVONDALE BAPTIST CHURCH CORPORATION

Pursuant to Section 617.1006 of the Florida Not For Profit Corporation Act, the undersigned Corporation adopts these Articles of Amendment to the Amended and Restated Articles of Incorporation.

FIRST: The name of the Corporation is AVONDALE BAPTIST CHURCH CORPORATION.

SECOND: The Amended and Restated Articles of Incorporation of this Corporation are amended by changing Article I so that, as amended, said Article I shall read as follows:

ARTICLE I

The name of the Corporation is GRACE CHURCH OF AVONDALE CORPORATION. The duration of the Corporation is perpetual.

THIRD: The amendment to the Amended and Restated Articles of Incorporation of the Corporation set forth above was adopted on February 19, 2006.

FOURTH: The amendment was adopted by the Members and the number of votes cast for the amendment was sufficient for approval.
