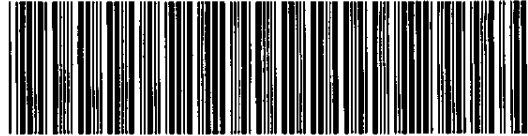



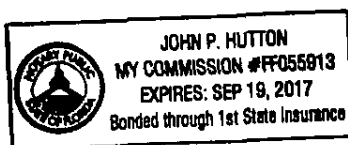

Amendment No. 6: Article 9.1, Articles of Incorporation

**ARTICLE 9
DIRECTORS**

9.1 Number of Qualification. The property, business, and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) nor more than five (5) directors. ~~Directors need not be members of the Association or residents of units in the Condominium.~~ Directors must be members of the Association. A director who ceases to be a member of the Association may serve until the expiration of their term.
