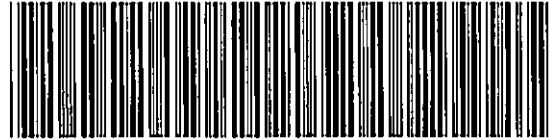



Enclosed for filing is a Resignation of Registered Agent for Hallandale Christian School, Inc. Also enclosed is a check in the sum of \$87.50 for the applicable filing fee. For the reason explained below, the corporation does not intend to appoint a successor registered agent and desires administrative dissolution as soon as permitted by law.

The corporation previously operated a pre-school that was affiliated with the Hallandale Haitian Mission of the United Methodist Church. That pre-school was closed and discontinued by the Mission, and the corporation was administratively dissolved in 2010. The active status of the corporation was mistakenly reinstated in 2016, however, by the former director of the pre-school, who is the resigning registered agent, without authorization of the board of directors of the corporation. None of the other directors listed in the corporation's Annual Report have been elected to serve as directors of the corporation since it was administratively dissolved or are even aware that they are currently directors of the corporation. Further, most of them can no longer be located to authorize the voluntary dissolution of the corporation. Accordingly, the enclosed Resignation of Registered Agent has been executed and is filed with the intention that it will result in the administrative dissolution of the corporation.
