Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**ARTICLE I  
Name of Corporation**

The name of the corporation shall be The Mary Brogan Museum of Art and Science, Inc.

**ARTICLE II  
Address of Registered Office and Registered Agent**

The present registered office of ODYSSEY Science Center/MUSEUM OF ART/TALLAHASSEE, INC. (hereinafter known and referred to as "The Mary Brogan Museum of Art and Science, Inc.") is 118 N. Gadsden Street, Tallahassee, FL 32301. The name of the present registered agent at the above address is Robert A. Weiss.

The new registered office of The Mary Brogan Museum of Art and Science, Inc. shall be 350 South Duval Street, Tallahassee, Florida 32301. The new registered agent located at that address is Rena Minar.

**ARTICLE III**

The date of adoption of the amendment was February 2, 2000.

**ARTICLE IV**

There are no members entitled to vote on the amendment. The amendment was adopted by the board of directors. The Board of Directors of The Mary Brogan Museum of Art and Science, Inc., consisting of twenty-eight (28) directors in office, held a meeting on February 2, 2000, at which a quorum was present. 


