To Whom It May Concern:

In October 2002, the University of Central Florida Retirement Association (FEI 59-2975471) elected new officers. It was brought to the attention of the Treasurer, Joseph Gomez that the Non-Profit Filing for 2002 had not been sent to the Division of Corporations. Mr. Gomez contacted your office and was informed that the corporation had been dissolved due to non-payment. He was asked to write a letter to the Dept. of State and to return the completed form along with a check for \$61.25 (chk #471) in order to be reinstated. Mr. Gomez did this on December 6, 2002 (see copy of attached letter).

The form was returned to the UCF Retirement Association along with a letter from Justin Shivers on December 11, 2002. Mr. Shiver's letter stated that the document was being returned because it had not been filled out in ink and that it should be resubmitted by January 31, 2003. Please note that the form does not state that it must be filled out in ink. *The check for \$61.25 was not returned.* This letter was received in the UCF Human Resources office on December 16, 2002. Due to an unfortunate clerical error, the letter was not forwarded to Mr. Gomez until April 15th, 2003. He was unaware that the form had been returned for correction, let alone that it needed to be resubmitted by a specific date.

As the check for \$61.25 was deposited by the Division of Corporations and officers of the UCFRA were unaware that they had missed a filing deadline, we request that you waive the \$175 reinstatement fee. The application has been completed in ink and is attached along with the supporting documentation. We also request any information regarding the 2003 filing and fees.
