Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

- ARTICLE III :** The purposes for which the corporation is organized are:
The worship of Almighty God according to the tenets of the Apostolic age writings that constitute the New Testament in the Holy Scriptures, and the proclamation of said Christian Faith among those in whatever land who have earlier received it.
- ARTICLE IV :** The qualifications for members and the manner of their admission are:
In the UNITED STATES and adherence to its teachings in their personal lives, walking in "newness of life" as the Scriptures require and continuing
therein. Those of adult status who do so are regarded as full members after they submit to water of baptism as stipulated in Christ's charge to the

- ARTICLE VII :** In event of dissolution, the residual assets will be turned over to remaining churches of this name and convention having the identical religious purpose and objectives, which are member congregations of the CHRISTIAN CONGREGATIONS of the UNITED STATES (National), which has been granted group exempt status under Section 501 (C) (3) of the Internal Revenue Code.

The foregoing amendments have the approval of the membership and are herein endorsed by those of the Administration, which is the administrative unit of the church in corporal matters.
