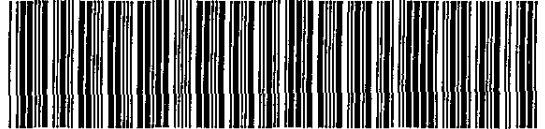

**III. SECTION THREE: MEMBERSHIP IN CORPORATION**

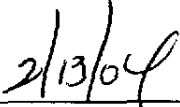
This Corporation has no Members with voting rights on the issue of dissolution. That right is reserved strictly for the Board of Directors.
