

ARTICLES OF AMENDMENT

- 1. The Articles of Incorporation of The Carriage House Condominium Association, Inc., a Florida corporation not-for-profit (the "Association"), created pursuant to Chapter 617, Florida Statutes were filed on April 30, 1990.
- 2. Pursuant to the provisions of Section 617.1006, Florida Statutes, the Association adopts the following Articles of Amendment to its Articles of Incorporation.
- 3. Section A of Article IX of the Articles of Incorporation is hereby amended as follows:

New Language is indicated by <u>underscored</u> type. Deleted language is indicated by struck through type.

The form of administration of the Association shall be by a Board of three (3) five (5) Directors.

All other Sections of Article IX remain unchanged.

4. Pursuant to Section 2 of Paragraph B of Article XII of the Articles of Incorporation, this amendment was approved by a majority of the members of the Association present at a duly noticed special meeting of the Association held on the 30th day of August, 2001 at which a quorum of members were present. The number of votes cast by the members was sufficient for approval of the amendment. Further, the amendment was approved and adopted by a majority of the Board of Directors ("Board") present at a Board meeting held on the 27 day of June, 2001.
